AGREEMENT TO SPEND TOWN HIGHWAY FUNDS FOR 2025

TOWN OF <u>VERONA</u> COUNTY OF <u>ONEIDA</u>

Pursuant to the provisions of Section 284 of the Highway Law, we agree that moneys levied and collected for the repair and improvement of highways, and received from the state or other sources for the repair and improvement of highways shall be expended as follows:

1.	GENERAL REPAIRS (5110 & 5120) The sum of § 568651.66 may be expended for general repairs upon 95.40 miles of town highways, including sluices, culverts, and bridges having a span of less than five feet and boardwalks or the renewals thereof.
2.	IMPROVEMENTS (5112) The following sums shall be set aside to be expended for the improvement of town highways for the calendar year of 2024:
