Call to Order with Pledge of Allegiance @ 6:01pm

A. Supervisors' Report:

Ken Brewer will not be with us today, due to an emergency at work.

B. Approval of minutes from the October 7, 2024, Regular Town Board Meeting.

Councilman Kahler made motion to approve minutes as presented.

Councilman Breckenridge seconded the motion.

C. Public Hearing: 2025 Budget Adoption @ 6:15 pm

Councilman Scherz motioned to open the public hearing at 6:18pm.

Councilman Kahler seconded the motion.

Good News, the tax rate has dropped from last year – \$1.86 per thousand, last year was (\$2.04 per thousand) Board was able to move funds and utilize surplus from 2024.

Projections from Oneida County for sales tax are 10-12% more over last year, HW held the line with expenses, added in new water system WD#3 – if there is a sales tax formula change (board has no say) or the economic devolvement funds (OIN \$350,000) changes in the future, changes will need to be made in the taxes – There will be additional monies laid out for the new water district. We will need to send a letter to the state, explaining there is no need for the Tax Cap.

RC: How much do we get for the cell phone tower?

TB: \$15,000 annually – it's on the ground lease, and we get extended coverage here at the building.

RC: If OIN owns the land, and leases it to another entity, do they have to pay taxes?

TB: This still falls under the agreement with the County / State no tax moneys will be collected.

The cap for the OIN to purchase is 25,000 acres across all of Madison and Oneida County.

Councilman Scherz motioned to close the public hearing at 6:37pm

Councilman Kahler seconded the motion.

## D. County Legislator Report.

Cynthia Witt: Reminded everyone that is breast cancer awareness month and to do self-exams, it saved her life.

Keith Scheibel: Norman Leech in Vienna tonight; Tornado relief funding, approved \$500,000 supplemental appropriation for Family and community Services, Money for Sherriff road patrol vehicles; Elections commissioners reappointed

#### E. Public Concerns

RC: House next to Scatches in New London, where is that at? It's dangerous.

TB: The owners have a couple weeks to respond to the violation notice/ticket. If there is no response from the owner, the town will have to take down the house, then the cost gets added to the tax bill for the parcel. There are several places around town that, that should happen with. It's a matter of the town taking on that cost, and waiting to get reimbursed.

RC: What about Canal St house?

TB: The owner was also sent a notice.

RC: Every year the state sprays the Cicero Swamp, why don't they spray the canal?

TB: Scott can write to the DEC for that, we don't own the land, therefore it has to be via the state.

RC: Did we send trucks to Rome for the Tornado clean up?

Billy: Yes, it was under the shared services agreement.

RC: What did Verona get out of it?

Billy: Rome helped with a 17' culvert in Verona Beach and always allows use of their equipment when asked.

RC: I see a new furnace out in the garage? What was decided on?

Billy: Propane boiler – 3 bids were accepted and Ber-more was the lowest.

RC: Sterling Road, paved not long ago – we dug it up and put in a pipe. Why?

Billy: the culvert collapsed on it. That is why the culverts on Germany Road were replaced this year, due to it being on the plan for paving in 2025.

RC: Low bid High bid stuff – (directed to Scott) last month you mentioned comparing apples to apples it doesn't compare, what does that mean?

TB: The county bid is sent out and each company has a scope of work that needs to be bid, some companies have additional options that are available. You can choose from the additional options/services that are needed per road/area.

RC: You choose Suit-Kote every year – they were the high bid.

Billy: They were not the high bid and they did pave and milling.

TB: Are you going to get in on the Bid?

RC: It doesn't matter, you don't have to use the County bid – you can bid it out yourself.

You don't use milling every year – it's separate.

TB: The Highway Superintendent runs the roads, he discusses with the Board, but it is the decision of the Superintendent. He has the training for roads management, we defer to him.

RC: On sidecut road they used more than 2" of pavement, it was close to 6-7" – there is no 2% grade. Start at the center of the road, not the edge.

TB: Billy starts looking at paving companies via the county Bid in the Spring, we will keep that in mind.

2. Discussion & Approval to accept the Map and Plan for the existing sewer districts for the proposed Comprehensive Pump Station Asset Renewal project.

Ken: Study start a while ago, a comprehensive evaluation of the pump stations that were built in the mid 90'2 and 100% paid for by the Oneida Indian Nation. Each station is about 30 years old. A few pump replacements and work over the years. With the expansion of the sewer districts, the pumps have started to hit their capacity. Improvement of facilities project, gives us a map and plan including flows, and maps of locations. A laundry list of improvements – project is just over 4million (included inflation) Identified max amount of \$4.24 million to be expended with a mid-point of construction of in 2026. All sewer users in Verona will use these upgrades. Nation accounts for about 84% of EDU's. Any debit service will also be allocated accordingly. 10 years at 4.5% interest – (no grants for this type of service) would equal about \$114 per EDU annually for residents.
