RC: For Billy, what is happening on Cornell Street with the paving? When it rains there are huge puddles. It's due to the rollers.

Did you figure out a plan for Germany Road yet?

Billy: It will be addressed in the Spring when the bids come out.

RC: Compaction on oil and stone paving – what is the max depth you should be going in one lift? Billy: 2.5"

RC: I have information that you can go 3'' - you push 4'' you are wasting money. When we measure over 2.5 inches we are beyond our specs. Do you have a coring machine?

RC: Resident Concern/Comment TB: Town Board

78 Billy: No

RC: If I was to come up with one, could we core the roads?

Billy: the center of the road where you would get an accurate ready yes - no problem

RC: Milling machine is supposed to start in the center not the side of the road. Rock road has puddles because it was not done correctly. You have had to notice the issues? The cost I received from Mr. Brewer is it cost \$88,000 to do Cornell St. – now we have ponds on it and it will cost more to fix it. This is a problem.

RC: Another question for Billy: A couple years ago, there was a catch basin issue over on Reber Road, you said the town doesn't own any catch basins there, it may be have put in 50-60 years ago. I asked you about the driveway, when you paved the road.

Billy: We came over and put patch down around the catch basin

RC: I went down and purchased material to feather the road into the driveway, that should have been done when the road was paved. And two years ago, the cross covert on Sand Hill Rd by Stickney Road was replaced—why did you put a smaller pipe in?

Billy: that was changed in the middle of the night

RC: you should never go to a smaller pipe, it should be the same or bigger, that poor neighbor now has their front and back lawn swamped when it rains

TB: why have you waited 2 years to address this issue?

RC: I've been sitting with it; it started to really bother me.
