# A. Supervisors' Report

- Water Project still moving ahead, foundations are in place for the pipe bridge
- Pump station is moving along looking at best case for water service 2<sup>nd</sup>/3<sup>rd</sup> quarter of 2026
- B. Approval of minutes from August 4, 2025, Regular Town Board Meeting.

C. Public Hearing @ 6:15pm: Durhamville Sewer Project Cost Amendment

Motion to open the Public Hearing at 6:17pm made by Councilman Scherz.

Councilman Brewer seconded the motion.

Ken Knutsen, gave overview of project. A Map Plan and Report were submitted and efforts have been made to solicit grant dollars. Looking at a 2028 construction season, therefore we need to inflate the cost to \$13.3 million, to take into account inflation and unforeseen expenses. This also allows us to apply for additional grant dollars. Public hearing is to hear from the residents that are within the district.

Public Concerns/Comments on the amendment:

RC: Does this sewer take away the need for individual septic's?

TB: Yes, this will aid those residents with the current issues, including fecal matter found in the canal.

Once the funding is in place for the current district, extensions will be researched and pursued if needed.

RC: Is everyone in the sewer/water line mandated to hook up?

TB: No, they are not required, but they will be responsible for the debt service.

RC: Is every residence being tested to be an issue or cause the existing problem.

TC: No, the area has been deemed unsafe, if we don't do something, the county will step in and they do not look for grants and so on, the cost could be much greater. Income surveys were completed and the area qualifies for a 0% loan for 30 years.

This is only the hamlet of Durhamville.

TB: I understand the lines of \$7.8 million for Construction \$2 million in Engineering costs \$3.2 million contingency — do we feel the \$3.2 million contingency will be spent?

RC: Resident Concern/Comment TB: Town Board

B&L: EFC requires, at this stage of the project is a 30% contingency.

TB: It's easy to reduce the cost and more difficult to increase the cost due to grant submissions and requests.

Kelly: We had 2, they came in late in the program, we need to work on advertising better for next year!

RC: Cornell St. kids in the road, that will not move out of the way, they hit the car – a parent slammed his hand on my window and yelled at me

TB: The Sherriff's need to be contacted, we have not authority

RC: There is also basketball hoops in the road that they will not move

TB: Do we know these kids?

RC: They just moved to the area, it's more than one family, the parents do not care that the kids are wandering around

This has been going on for months, there have been numerous complaints and calls to the Sherriff's and Troopers. The most recent was on the 16<sup>th</sup>, a neighbor called the sheriffs, because the kids put a dent in her house. The kids, dug up all rock at end bay of FD property. Neighbors are directly being harassed by the kids as well. They are all ages, toddler up to teenagers. They are taunting neighborhood dogs, and individuals that are outside in their own yard. Sherriff said that the FD is a public building, so if someone gets hurt it's on the property owner. They broke the lights on the tree and deer, twice in the memorial park. Threats on Social Media from the parents to the general public about their kids getting charged and the repercussions to the residents.

TB: Kelly will get personal information and send to Scott. Scott will reach out to the Sheriff's and the Troopers.

RC: Who is in charge of the men working on the pump station?

TB: We ultimately are.

RC: We have asked repeatedly that they not park in in front of the bay doors. TB: We will again speak with them, Ken (B&L) will contact the onsite director.
