**IN THE MATTER OF
ESTABLISHMENT OF THE TOWN OF VERONA
DURHAMVILLE SEWER DISTRICT
PURSUANT TO ARTICLE 12-A OF THE TOWN LAW
IN THE TOWN OF VERONA,
COUNTY OF ONEIDA, STATE OF NEW YORK**

Councilor Brewer moved and Councilor Kahler seconded the following resolution:

WHEREAS, pursuant to Town Law Article 12-A, the Town Board of the Town of Verona, New York (the “Town”), previously approved the establishment of sewer system improvements to be known and identified as the Durhamville Sewer District (the “Sewer District”) on July 3, 2023 (Resolution No. 23-006), with a maximum amount proposed to be expended for construction of Eleven Million, Two Hundred Thousand and 00/100 Dollars (\$11,200,000.00) and an estimated cost of the Sewer District to the “typical property” of Eight Hundred Twenty-Three and 00/100 Dollars (\$823.00); and

WHEREAS, by letter dated November 17, 2024, the Town Board submitted an Application for the New York State Comptroller’s approval of the Sewer District, pursuant to Town Law § 209-f; and

WHEREAS, in waiting for the approval of the State Comptroller, costs for construction of the Sewer District have risen and the Town Board has also secured grants for the Sewer District, such that the estimated cost of the Sewer District to the “typical property” has changed; and

WHEREAS, because the Sewer District as originally established has not yet been approved by the State Comptroller, the Town Board has determined that reforming the Sewer District and establishing the Sewer District anew based on the changed construction cost and changed estimated cost to the “typical property” is the best course of action; and

WHEREAS, a Map, Plan and Report has been duly prepared in such manner and in such detail as heretofore has been determined by request by the Town Board relating to the establishment and construction, pursuant to Town Law Article 12-A, of the Sewer District; and

WHEREAS, said Map, Plan and Report, dated July 2021, last revised May 2026, has been prepared by Barton & Loguidice, a competent engineering firm duly licensed by the State of New York, and has been filed in the office of the Town Clerk where it is available for public inspection; and

WHEREAS, the boundaries of the proposed Sewer District consist of those areas within the Town of Verona as set forth in Schedule “A” attached hereto and made a part hereof; and

WHEREAS, the Sewer District improvements include those described in the Map, Plan and Report and consist generally of the construction of: a low-pressure collection system, with approximately 4,900 linear feet (LF) of 6” HDPE force main, 5,220 LF of 4” force main, 7,100 LF of 3” force main, 9,150 LF of 2” force main, as well as thirty-four (34) force main cleanouts,

seven (7) air valve manholes, two hundred twenty-three (223) grinder pumps and lateral kits, one (1) duplex grinder pump and later kit, six (6) spare grinder pump cores and two hundred twenty-three (223) 1¹/₄" service laterals and 4" building sewer connections to the grinder pump, along various roads in the Town of Verona; the proposed Sewer District will connect to City of Oneida infrastructure at Bennett Road to flow to the City of Oneida Wastewater Treatment Plant; and

WHEREAS, the maximum amount proposed to be expended for the creation and construction of the Sewer District is estimated to be Thirteen Million, Three Hundred Thousand and 00/100 Dollars (\$13,300,000.00) and the plan of financing includes the issuance of bonds of the Town to finance said cost and the assessment, levy and collection of special assessments shall be borne entirely by the properties located within the described benefitted areas including the several lots and parcels of land within said benefitted areas as associated with the Sewer District, which the Town Board shall determine and specify to be especially benefitted thereby, so much upon and from each as shall be in just proportion to the amount of benefit conferred upon the same, to pay the principal of and interest on said bonds as the same shall become due and payable, as generally described in Schedule "B" and as set forth more fully in the Map, Plan and Report, and further that the Town of Verona has sought and obtained public sources of funding and financing through the New York State Environmental Facilities Corporation ("NYSEFC"), being awarded an Enhanced WIIA Grant from NYSECF, and the United States Environmental Protection Agency ("EPA"), being awarded an EPA STAG Grant, and will continue to seek and obtain other public sources of funding and financing, for the construction and administrative costs associated with the creation and construction of the Sewer District; and

WHEREAS, the estimated cost of the Sewer District to the "typical property" is Eight Hundred Seventy-Five and 00/100 Dollars (\$875.00); and

WHEREAS, the estimated cost of the Sewer District to the “typical one-family home” is Eight Hundred Seventy-Five and 00/100 Dollars (\$875.00); and

WHEREAS, the estimated cost of the Sewer District to a “two-family home” is One Thousand, Seven Hundred Fifty and 00/100 Dollars (\$1,750.00); and

WHEREAS, there are no estimated hook-up costs because the project was designed as a “turn-key” project; and

WHEREAS, the cost and expenses of operation and maintenance of said Sewer District, shall be a function of charges to the benefitted property owners and shall not be a general charge against the Town; and

WHEREAS, the Town Board has heretofore caused to be prepared and filed for public inspection with the Town Clerk, a detailed explanation of how such estimates were computed; and

WHEREAS, the Town Board previously conducted an environmental review of the proposed Sewer District pursuant to the New York State Environmental Quality Review Act (“SEQRA”) and determined that the project is a Type I Action and that a Full Environmental Assessment Form would be prepared, declared that the Town Board would act as lead agency and directed that lead agency notices be sent to involved/interested agencies; and

WHEREAS, having given due consideration to the impact that the creation and construction of the Sewer District may have on the environment, on June 5, 2023, the Town Board determined that the project would not have a significant impact on the environment and therefore issued a Negative Declaration for purposes of SEQRA; and

NOW THEREFORE, BE IT RESOLVED AND ORDERED that the Town Board readopts and reaffirms the Negative Declaration issued by the Town Board on June 5, 2023 for the purposes of SEQRA; and it is further

RESOLVED AND ORDERED that a hearing of the Town Board of the Town of Verona shall be held at Verona Town Hall located at 6600 Germany Road, Durhamville, New York on June 1, 2026 at 6:00 p.m., or as soon thereafter as the matter can be heard to consider the establishment, creation and construction of the proposed Town of Verona Durhamville Sewer District herein referred to and to hear all persons interested in the subject thereof, concerning the same and for such other action on the part of the Town Board with relation thereto as required by law; and it is further

RESOLVED AND ORDERED that the Town Clerk cause a copy of this order to be published once in a newspaper having a general circulation in the Town and previously designated as the official newspaper of the Town for such purposes and to also post a copy thereof on the Town's official signboard maintained pursuant to Section 30(6) of the Town law; and to further place a copy of this order upon the Town's website, all as certified by the Town Clerk, the first publication thereof and said posting are to be not less than 10 nor more than 20 days before the day designated for the hearing as aforesaid, all in accordance with the applicable provisions of the Town Law; and it is further
